NOTICE OF RACE

The Organizing Authority for the 2013 Harbor 20 North-South Challenge will be:
The Santa Barbara Yacht Club (SBYC), 130 Harbor Way, Santa Barbara, CA 93109

1. RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).
- 1.2 The US Sailing prescriptions to rules 60, 63.2, and 63.4 will not apply.

2. ELIGIBILITY, ENTRY, AND FORMAT

- 2.1 The regatta is open to members in good standing of the Harbor 20 fleets of Newport Harbor (Fleet 1) and Santa Barbara (Fleet 4).
- 2.2 Five teams from Fleet 1 and five teams from the Fleet 4 may enter as dictated by each fleet. Each team will consist of three crew total. North teams will consist of two Santa Barbara (Fleet 4) crew and one Newport (Fleet 1) crew. South teams will consist of two Newport (Fleet 1) crew and one Santa Barbara (Fleet 4) crew.
- 2.3 Eligible competitors may enter by completing the entry form available at <http://sbycracing.org/2013-H20-north-south/> and submitting the required entry fee to the Santa Barbara Yacht Club by the entry deadline.
- 2.4 No entries will be accepted after Saturday, August 31st at 1000 hours.

3. FEES

- 3.1 Entry Fee is \$150 per Harbor 20 competitor and includes the below listed social events, charter fees, and lodging.
- 3.2 Spectators wishing to attend dinners and parties may purchase tickets for \$125 per person.

5. SAILING INSTRUCTIONS

- 5.1 Sailing Instructions will be available online at <http://sbycracing.org/2013-h20-north-south/> approximately two weeks prior to the event and at registration.

6. VENUE

- 6.1 The Santa Barbara Harbor, the Santa Barbara Yacht Club, and parking lots are as shown in 'Attachment A – Santa Barbara Harbor Map'.
- 6.2 The racing venue shall be the Santa Barbara Channel within 1 mile of SBYC.

7. COURSES

- 7.1 A course chart will be attached to the Sailing Instructions. Courses will be a windward-leeward buoy configuration as described therein.

8. PENALTY SYSTEM

- 8.1 Rule 44.2 will be modified so that a boat that has broken a Rule of Part 2 may take a penalty of one turn including one tack and one gybe.

9. SCORING

- 9.1 The low-point scoring system of Appendix A will apply.
- 9.2 A boat's series score will be the total of her race scores.
- 9.3 One race must be completed to constitute a series.

10. PRIZES

- 10.1 Take home trophies will be awarded to the top finisher(s) in each class, based on participation.

11. DISCLAIMER OF LIABILITY

- 11.1 Competitors participate in the regatta entirely at their own risk. See Rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

12. INSURANCE

- 12.1 Each participating boat shall be insured with valid third-party liability insurance with adequate limits for this event, or the equivalent.

13. AMENDMENTS TO THIS NOTICE

- 13.1 The Organizing Authority reserves the right to amend this notice. Any amendments of this notice made before August 30th, 2013 will be posted on the Harbor 20 North-South Challenge event webpage (<http://sbycracing.org/2013-h20-north-south/>). Amendments made after this time will be posted on the official Notice Board and on the event webpage.

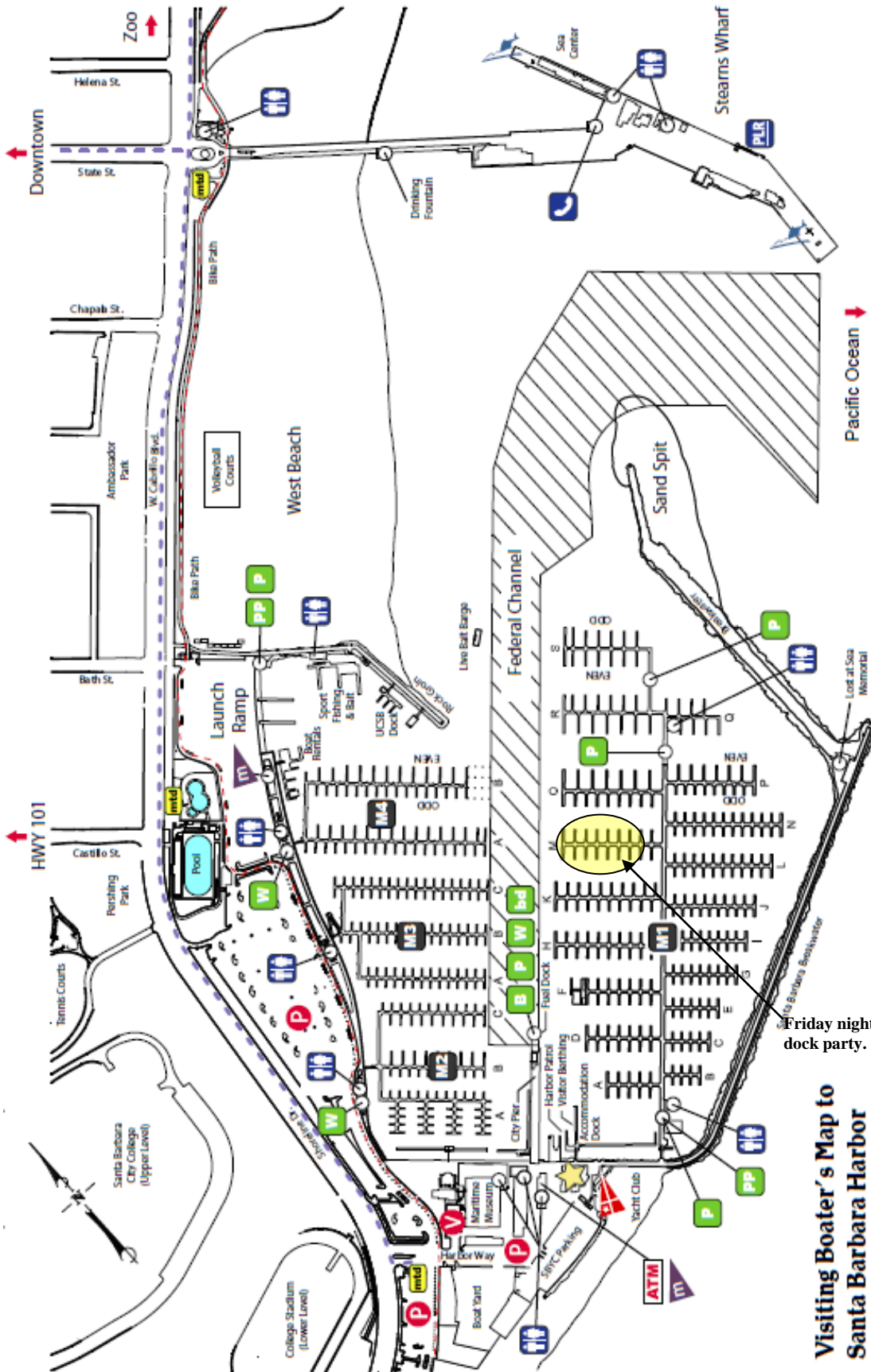
